## CPR and First Aid Training Changes!

Due to new Heart Association regulations the schedule and fees for CPR and First Aid/CPR Trainings offered through the HCDCA have changed and from this date forth until further notice, will be as follows :

- ◆ No CPR/First Aid classes will be taught in the months of June, July, August, or December.
- ◆ CPR (only) will be taught on the second Thursday of the month (4-8:30 pm)
- ◆ CPR/First Aid will be taught on the Saturday following the second Thursday of the month (8am—2 pm)
- ◆ Fees/class: \$35 one-time membership fee to join the HCDCA, \$3 dues/staff member/year, \$30 (includes \$25 instructor fee and \$5 fee charged by college for the card)
- ◆ Money Order or Cashiers Check (NO personal or business checks accepted)
- ◆ Payment is DUE two weeks prior to the class (due to mandated lower ratios.)
- ◆ Please call HC CCR&R to reserve the appropriate number of slots in the class prior to mailing payment to Brenda Lucas.

Phase I for the Subsidized Early Education for Kids (SEEK) attendance reporting system is postponed a minimal of thirty (30) days from June 1<sup>st</sup> due to "secure connectivity" issues that must be resolved before moving forward toward implementation. The Division of Child Development will provide further details as soon as possible to establish a new Phase I start date. This announcement includes all scheduled events for SEEK Phase I only.

Phase II, the SEEK payment delivery start date remains effective October 1<sup>st</sup>.
