Notice to Bidders

Separate sealed bids, subject to the conditions herein, will be received until 2:00 PM., November 15, 2018, at Harnett County Finance Department, 420 McKinney Parkway, PO Box 760 Lillington, NC 27546, and then opened and publicly read for furnishing all labor and materials and performing all work connected with: **Shawtown School Bldg Renovation**, as indicated in the plans specifications Project Number 2018-009, date: July 2018.

The project shall consist of furnishing all labor, materials and equipment and performing all work required to satisfactorily complete the Shawtown School Building project. Work includes demolition and renovation of structure at 645 Shawtown Road, Lillington, NC 27546.

Each bid must be accompanied by a Bid Bond, a deposit of cash or certified check payable to the County of Harnett, and drawn on some bank or trust company authorized to do business in the State of North Carolina, for an amount equal to 5% of the total base bid, as a guarantee that the bid is accepted, the required Contract will be executed and the required Performance Bond and Payment Bond furnished within fifteen (15) days after written notice for formal award of Contract.

Envelopes containing proposals must be sealed, addressed to Ms. Renea Warren-Ford, Procurement, Harnett County Finance Department, 420 McKinney Pkwy, Lillington, NC 27546, and marked on the envelope as follows:
