Each library has a bookdrop permitting 24-hour return of materials.

Who may have a library card?

Anyone who can write his or her own name and

- lives in Harnett County, or
- lives in a contiguous county, or
- attends school in Harnett County, or
- owns property in the county, or
- works in the county.

We need to see a picture identification and something showing applicant's current mailing address. A current driver's license is usually sufficient. First time patrons may check out two items. After the initial transaction, limits are outlined in the *Procedures Manual*.

Any applicant under age 16 needs a parent or guardian to come in with him or her to grant parental permission at the time he or she gets the card.

Public Library System

Harnett County maintains a network of public libraries to serve the residents of Harnett and surrounding counties. These are independent libraries that share access to their individual holdings so that any library user can request anything owned by any one of the constituent libraries.

Borrowing Periods

| | |

| Books, Audio | 3 weeks |
| Magazines, Kits | 1 week |
| Videos/DVDs | 3 days |

Three-week items (books, books on CD or cassette, and music CDs) may be renewed once unless they are on reserve for another patron. **Videos/DVDs and periodicals may not be renewed.** For items that are renewable, you may call any library or visit any library to renew your items. You may also renew items via the library catalog at www.harnett.org/library if they are not overdue. Items are overdue after closing on the day they are due. (See checkout receipt for specific times.)

Fines begin on the 10th day after a three-week item is due; the fine is \$1.00 and goes up \$.10 each day afterwards. The fine for a three-day item is \$.50 per day and begins after closing on the day an item is due. The fine for a one-week item is \$.10 per day and begins after closing on the day an item is due.

Notification that you have overdue items will be made 14 days after the grace period for books and 14 days after the due date for videos/DVDs. If items are not returned, you will be billed for items borrowed and you will receive a letter from the County Attorney. Your borrowing privileges will be suspended after you receive a bill until your record has been cleared. You will then be on probation for a year, with limited borrowing privileges.

Maximum fines charged will be \$10.00 for books and \$20.00 for videos/DVDs.
