## RULES FOR USE OF FACILITIES: HARNETT COUNTY PARKS

Harnett County Parks and Recreation facilities may be made available to responsible recognized civic, business, or religious organizations in the community for worthy community activities, subject to the following provisions, and such rules and regulations as the Board of Commissioners may from time to time prescribe.

1. Application for use of facilities must be made in writing and signed by an authorized representative of the organization applying.
2. Park and Recreation Department activities have priority in scheduling.
3. The applicant, organization or group using Park facilities is liable for any damages to facilities or any injuries or damages sustained by any individual or organization while the facilities are being used by such applicant, organization or group and, said applicant, organization or group shall indemnify and save harmless the Harnett County Board of Commissioners and their employees from any and all claims made by any person or organization for injuries or damages sustained during use of facilities by such applicant, organization or group.
4. Applicants will be responsible for all phases of activity for which facility use is granted. Improper conduct, including use of intoxicating beverages or drugs on the premises, will not be tolerated. The conduct of all persons present and in attendance, and reasonable care of the facility, shall be the responsibility of the users.
5. There shall not be any changes in electrical wiring, lighting equipment, or public address system without the specific permission of the Director of Parks and Recreation Department.
6. The user must be responsible for orderly parking, and when necessary furnish police protection. Damages to park grounds, resulting from improper parking, shall be the responsibility of the user.
7. Concessions
  - A. No concession privileges will be extended by virtue of rental of facility. Concession privileges must have the approval of the Director of Parks and Recreation.
  - B. The user/applicant is responsible for obtaining and following all NC Board of Health regulations concerning the preparation and selling of food items. In addition to following required sanitation regulations, no alcohol or tobacco products may be sold.
8. No games nor practice sessions will take place on wet fields.
9. Failure to follow any of the above rules could result in the use of facility being denied.
