Emergency Conservation Program (ECP)

- Repairs damage to farmland caused by a natural disaster
- Debris removal
- Grading shaping, leveling land

Livestock Indemnity Program (LIP)

- Replaces 75% of average fair market value of livestock whose death was a result of adverse weather and in excess of normal mortality

Emergency Livestock Assistance Program (ELAP)

- Covers death losses of livestock, honeybees, and farm-raised fish not covered by other FSA programs

Environmental Quality Incentives Program Disaster Recovery (EQIP Disaster Recovery)

- Emergency Animal Mortality Management conservation practice
- Sustained losses qualifying as a mass mortality event defined as >20% mortality for poultry/swine or 10+ head cattle/equine

Emergency Watershed Protection Program (EWP)

- EWP can help communities restore damaged and destroyed infrastructure
- Protect what structures are still intact but may be threatened due to soil erosion and barren soil

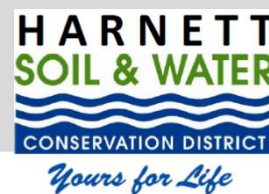

Disaster Recovery Program of 2018 (DRP)

- Assists with best management practices that will address soil impacts and farm infrastructure in order to protect water quality
- Irrigation ponds
- Farm access roads
- Hay fields/pastures
- Lagoon management
- Field conservation practice repair (waterways, terraces, etc.)

Agricultural Disaster Program of 2018 (ADP)

- NCDA program in partnership with NC Cooperative Extension for online application support
- Verifiable crop or livestock loss
- Commodities planted but not harvested before September 13, 2018
- Includes traditional crops, specialty crops, nursery stock, fruit trees/bushes, turf, and forages
- Livestock/poultry producers who qualify for LIP via FSA

Emergency Forest Restoration Program (EFRP)

- Restore forest health due to damage from natural disasters
- Debris removal for new stand establishment
- Site prep, planting materials and labor
- Restoration of roads, fire lanes, fuel breaks, or erosion control structures

Timber Restoration Fund (TRF)

- Site prep and tree planting sub-practices only
- Availability TBD
