## **Running for Office in 2026**

## When do I file? Filing periods are set by § 163-291.

- 12:00 noon December 1, 2025 12:00 noon December 19, 2025, State/County offices
- 12:00 noon June 8, 2026 COB July 6, 2026, Soil and Water

# What are the qualifications?

- https://www.ncsbe.gov/candidates/filing-candidacy/general-candidate-requirements
- Must be registered with party 90 days before filing
- Sheriff candidates must bring felony disclosure form with them to file

# What do I need to bring?

- o A valid NC Driver's License or other photo ID for identification purposes.
- o Payment method for filing fees: Filing fees at bottom page.
- Fees up to and including \$50.00 may be paid by cash, check, cashier's check, certified check, or money order.
- Fees over \$50.00 must be paid by check, cashier's check, certified check, or money order and made out to: Harnett County Board of Elections

## What can I expect when I arrive?

- If arriving on the first or last day of filing, please be prepared to wait.
- Staff will verify your eligibility to file for office.
- Filing paperwork will be completed, signed, and notarized by staff.
- o Filing fees must be paid at the time of filing.

#### **Campaign Finance Information**

- Your first campaign finance disclosure report is due within ten (10) days of your organized date on your Statement of Organization.
- New committees: Treasurers must receive training within 90 days of appointment and once every four (4) years thereafter.
- Please use the free, state-provided campaign finance reporting software for all report filings. The software download is located on the NC State Board of Elections website.
- o Existing candidate committees: Please ensure all information is current.

# Filing begins 12:00 noon December 1, 2025 and ends 12:00 noon December 19, 2025.
