Every three years local public health agencies throughout North Carolina conduct a comprehensive Community Health Assessments. The Harnett County Health Department along with community partners released the **2022 Community Health Assessment** (CHA). Core members of the Community Health Assessment Team included representatives from Harnett Health, Cape Fear Valley Health Systems, Campbell University Department of Public Health and Healthy Harnett. The team outlined a series of activities for collecting secondary and primary data throughout 2022.

The 2022 CHA reflects an investment by several organizations to understand community needs from the perspective and experiences of residents. The vision for the community health assessment process is "synthesizing health data with the voices in our community to chart a course toward a healthy community for all in Harnett County."

Community members have rated these concerns as significant with regard to the urgency, severity, and feasibility of improvement efforts.

- Harnett County's health priorities are 1. **Behavioral Health** (including substance use disorder and overdose prevention),
 - 2. Chronic Disease and 3. Motor Vehicle Injuries.

Next Steps: As this report is now completed, several next steps are needed to move the CHA from assessment to action:

- 1. Results from the 2022 Community Health Assessment will be disseminated to the community via online access, community organizations, media, and promotion through partnerships.
- **2.** Action plans outlining evidence-based strategies to address the county's health priorities will be developed and submitted to the state.
- **3.** An annual State of the County's Health (SOTCH) Report will be compiled and released to provide timely updates on health indicators related to our community and the work surrounding our health priorities.
