Exception: Permanently tagged and apportioned motor vehicles must be listed as they are not included on NCDMV registration renewal notices.</p> <p><b>Unlicensed Vehicles</b> - Vehicles not licensed with the North Carolina Division of Motor Vehicles must be listed. Vehicles include cars, trucks, trailers (all types), motorcycles, campers, and motor homes.</p> <p><b>Watercraft (Boats)</b> - Watercraft information may have been obtained from the NC Wildlife Commission. Please make corrections as needed. Be sure to list the year, manufacturer, and horsepower for all watercraft motors. You must also list boat trailers that are unregistered as of January 1, or have a multi-year registration plate.</p> <p><b>Aircraft</b> - Aircraft owners must provide the year, make, and model of the aircraft, along with the tail number. Please provide engine hours and engine maintenance information to aid in valuation.</p> <p><b>Manufactured Homes</b> - Manufactured home owners must provide the year, make, model, VIN, and size of the manufactured home. If you have sold a manufactured home listed on this form, please provide information for the new owner in section A of this form.</p> <p>Please provide as much information as possible to ensure the property can be valued accurately.</p>
<b>E</b>	<b>Affirmation</b>	<p>Signature must be that of the owner, partner, or principal officer or individual having power of attorney.</p> <p>Any individual who willfully makes and subscribes an abstract (listing) required by this Subchapter (of the Revenue Laws) which individual does not believe to be true and correct as to every material matter shall be guilty of a Class 2 misdemeanor. (Punishable by a fine not to exceed \$1,000 and/or imprisonment up to 60 days.)</p>
	<b>Military Personnel</b>	All military personnel owning personal property in Harnett County must sign and return this abstract to the tax office by January 31. Active duty, non-resident service members may be exempt from paying personal property taxes in NC. To claim exemption, submit a copy of your Leave and Earnings Statement with your signed abstract. Spouses of active duty, non-resident service members may also be exempt if they elect the same state of residency as the service member. To claim exemption, submit a copy of the spouse's military ID, service member's LES, and proof of residency for the state claimed with your signed abstract.
	<b>Tax Relief</b>	<p><b>Elderly/Disabled Exclusion</b> - North Carolina excludes from property taxes, the greater of twenty-five thousand dollars (\$25,000) or fifty percent (50%) of the appraised value of a permanent residence owned and occupied by a qualifying owner. A qualifying owner is an owner who meets all of the following requirements as of January 1 preceding the taxable year for which the benefit is claimed:</p> <ul style="list-style-type: none"> <li>• Owner must be at least 65 years of age or totally and permanently disabled.</li> <li>• Owner has an income for the preceding calendar year of no more than thirty-three thousand eight hundred dollars (\$33,800).</li> <li>• Owner is a permanent North Carolina resident.</li> </ul> <p><b>Circuit Breaker Exclusion</b> - If you are at least 65 years of age or totally and permanently disabled, have owned and occupied the property at your permanent residence for at least five (5) years, and your income for the preceding calendar year was no more than fifty thousand seven hundred dollars (\$50,700), you might be eligible for this exclusion.</p> <p><b>Disabled Veterans Exclusion</b> - Veterans who are permanently disabled due to a 100% service connected disability, or their unremarried surviving spouses, may qualify to have the first forty-five thousand dollars (\$45,000) of the appraised value of their permanent residence excluded from taxation.</p> <p>Information and applications for these tax relief programs are located online at <a href="http://www.harnett.org/tax/exemptions.asp">www.harnett.org/tax/exemptions.asp</a>, by calling our office at 910-893-7520 or by visiting our office located at 305 West Cornelius Harnett Boulevard, Suite 101, in Lillington..
