Α	Ownership Information	Please review name, mailing address, and physical location of property and make necessary corrections using the space provided. Ownership is determined as of January 1 of the tax year indicated. If you sold a manufactured home during the preceding calendar year, please provide new owner information in the space provided.

E	Affirmation	Signature must be that of the owner, partner, or principal officer or individual having power of attorney. Any individual who willfully makes and subscribes an abstract (listing) required by this Subchapter (of the Revenue Laws) which individual does not believe to be true and correct as to every material matter shall be guilty of a Class 2 misdemeanor. (Punishable by a fine not to exceed \$1,000 and/or imprisonment up to 60 days.)								
	Military Personnel	All military personnel owning personal property in Harnett County must sign and return this abstract to the tax office by January 31. Active duty, non-resident service members may be exempt from paying personal property taxes in NC. To claim exemption, submit a copy of your Leave and Earnings Statement with your signed abstract. Spouses of active duty, non-resident service members may also be exempt if they elect the same state of residency as the service member. To claim exemption, submit a copy of the spouse's military ID, service member's LES, and proof of residency for the state claimed with your signed abstract.								
	Tax Relief	Elderly/Disabled Exclusion - North Carolina excludes from property taxes, the greater of twenty-five thousand dollars (\$25,000) or fifty percent (50%) of the appraised value of a permanent residence owned and occupied by a qualifying owner. A qualifying owner is an owner who meets all of the following requirements as of January 1 preceding the taxable year for which the benefit is claimed: • Owner must be at least 65 years of age or totally and permanently disabled. • Owner has an income for the preceding calendar year of no more than thirty-three thousand eight hundred dollars (\$33,800). • Owner is a permanent North Carolina resident. Circuit Breaker Exclusion - If you are at least 65 years of age or totally and permanently disabled, have owned and occupied the property at your permanent residence for at least five (5) years, and your income for the preceding calendar year was no more than fifty thousand seven hundred dollars (\$50,700), you might be eligible for this exclusion. Disabled Veterans Exclusion - Veterans who are permanently disabled due to a 100% service connected disability, or their unremarried surviving spouses, may qualify to have the first forty-five thousand dollars (\$45,000) of the appraised value of their permanent residence excluded from taxation.
